- 1. The minimum number of golfers that the event will be billed for is () players.
2. The tournament contact is responsible for calling the golf shop with an approximate number of golfers 2 weeks prior to the event and the FINAL count of golfers is due no later than 5 days prior to the event.
3. Payment in full is due the day of your tournament. Morgan Hill accepts payment by cash, check, money order, Visa, Master Card, Discover or American Express.
4. All food and beverage including alcohol MUST be purchased through Morgan Hill.
5. Morgan Hill requests that all personal property be picked up within 24 hours of the completion of the event.
6. It is the responsibility of the event host to communicate Morgan Hill's Dress Code to the participants of the event.
7. Should the event need to be postponed due to inclement weather prior to tee off, the event shall be re-scheduled within 60 days of the original date subject to availability.
8. In the event of inclement weather after tee off on the day of the event, all parties are obligated to the terms of the original contract.
9. The organization hosting the event at Morgan Hill will be held responsible for any damages done to any Morgan Hill property, including, but not limited to, damage done to the golf course or golf carts.

COVID-19/ PANDEMIC ASSUMED RISK CONTRACT

Morgan Hill Golf Course is taking measures and precautions to assist you to voluntarily proceed with your Outing or Event and is implementing the following precautions for all events:

- A mask must be worn in accordance with state and local requirements. If required by law or Order of the Governor of Pennsylvania or any department, bureau, or agency of the Commonwealth and any of its political subdivisions and agencies, departments and representatives thereof, attendees without a mask will be denied entrance to the venue/event.
- Social distancing will be enforced during the event and staging will be arranged accordingly.
- Hand sanitizer stations will be set up at the venues.
- Food and beverage will be packaged and served in a manner that minimizes contact between attendees and service staff.
- Attendees are expected to act in a responsible manner and to observe and comply with all COVID-19 safety protocols. Morgan Hill Golf Course reserves the right to remove any attendee that does not follow these guidelines.

By agreeing to proceed with the planned event, I/We acknowledge and agree: (1) that an inherent risk of exposure to COVID-19 exists in any public place where people are present; (2) to assume all risks that I may be exposed to or infected by COVID-19 or any other communicable disease while attending or participating in activities hosted on the premises of Morgan Hill Golf Course ; (3) on behalf of myself and my personal representatives, assigns, heirs, next of kin and others with whom I may interact and invite to attend as guests to the Outing or Event, not to hold Morgan Hill Golf Course, and/or the owner of any premises where such activities are conducted and their respective officials, officers, directors, employees, volunteers, contractors, servants, sponsors, agents, representatives, successors, heirs and assigns (collectively "Releasees") liable for any risks, injuries, illness, infections, death or damages arising because of my attendance and/or participation at the program; (4) to RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, DEFEND and COVENANT NOT TO SUE on behalf of myself and my personal representatives, assigns, heirs, next of kin and on behalf of others with whom I may interact and invite to attend as guests to the Outing or Event, any or all of the Releasees for any injuries, illness, infections, death or damages and/or any claims or demands arising from or related to my attendance and/or participation in the program; and (5) to INDEMNIFY, DEFEND AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, claim, demand, expense and cost they may incur arising out of or related to my attendance and/or participation in the program including, but not limited to, all legal, professional and expert fees incurred.
