Please read & review. Initial each to demonstrate understanding of our collective membership policies.

- **Tee Time Policy:** Members are allowed to book two weeks in advance. Members are only allowed to book or reserve one foursome per day, unless otherwise approved by management. Members cannot book multiple tee times for other Members. If multiple groups are playing back-to-back, each tee time must have a different Member reserving the time. The Member booking the time is responsible for the entire group booked and is subject to No Show Policy rules in the case any of their group does not arrive at the scheduled tee time. Initial _____
- **No Show Policy:** All members must appropriately cancel or reschedule their tee times at least 24 hours prior to their scheduled tee time. Failure to do so will mean this member is responsible for the players that failed to show under the original tee time scheduled. The credit card on file will be charged at the time of the scheduled tee time. Initial _____
- **Check-In Policy:** All Members must individually come into the golf shop to check in and obtain a starter slip from the counter staff each time they play. Once received, this slip must be given to the starter. If no starter is present, it must be given to the outside bag drop off staff. If the member/lessee is playing golf at a time outside the allowable structure of their membership, all green fees must be paid for before the round begins. Initial _____
- **Cart Lease and Liability Policy:** Member/Lessee agrees to keep golf cart in the same condition as received and agrees to be financially responsible for any damages caused to the golf cart, property, or personal injury. Member/Lessee agrees that the Morgan Hill Golf Course /Lessor is not liable for any type of damages including person or property damage arising from the use of the cart. Member/Lessee agrees that the cart was received in good order and agrees to pay Morgan Hill Golf Course /Lessor for all damages to the cart that occur during the rental. Member/Lessee agrees that no more than 2 persons and 2 bags can occupy the golf cart. Member/Lessee acknowledges that he/she is 16 years or older and will be the only individual to operate the golf cart. Acceptance of this receipt constitutes a contract. Member/Lessee understands that golf is a hazardous activity and assumes and accepts all risks of injury including both physical harm or property damage while at Morgan Hill Golf Course. Member/Lessee holds harmless Morgan Hill Golf Course, its officers, affiliates, employees, all associated with the course from any claim, lawsuit, or demand. No alcoholic beverages shall be brought on to golf course property and the facility has the right to confiscate any outside alcohol at any time. Initial _____
- **Weather Policy:** Morgan Hill Golf Course will notify players to the best of our ability in the case of inclement weather. Playing golf in inclement weather is considered to be "at your own risk." Please be advised you accept and acknowledge that risk when you play the facility. Initial _____
- **Pace of Play Policy:** Morgan Hill Golf Course will strictly enforce a 4 hour and 25-minute pace of play for 18 holes. Members are asked to follow the pace accordingly. Initial _____
- **Golf Etiquette Policy:** Members are expected to be checked in and ready for starter instructions 10 minutes before their scheduled tee time. If you are late for your tee time you will forfeit your tee time. All golfers are expected to follow proper golf etiquette on the golf course including but not limited to, never entering private property, playing music at a reasonable level and following dress code

standards. Please be advised if a golfer strikes a home or car with a golf ball the player is responsible for all damages. Initial _____

- **Code of Conduct/ Ethics Policy:** Members are expected to conduct themselves in a proper manner that represents the professionalism and core values in which the Morgan Hill professional staff exhibits. Any breach in this code of ethics will result in 2 warnings before a termination of membership. First infraction will be a written warning of the infraction. Second infraction will be a written warning accompanied with probationary time period and suspension of membership services. Third infraction will be grounds for termination of membership with no eligibility for refund toward the membership services. Initial _____
- **Force Majeure Clause:** Morgan Hill Golf Course will not refund membership fees for golf course closers outside the control of the club. Morgan Hill Golf Club shall not be held liable for failure of or delay in performing its obligations under this Membership Contract if such failure or delay is the result of: an act of God, such as lightning, high winds, earthquake, hurricane, tornado, flooding, or other natural cause or disaster; or in the case of war, action of foreign enemies, terrorist activities, labor dispute or strike, government sanction, blockage, embargo, or failure of electrical service; or in the event of epidemic, pandemic, outbreak of disease or pestilence, government shut-downs or limitations, or impossibility or impracticability of performance of any nature outside of the control of Morgan Hill Golf Club, including but not limited to unanticipated staff reductions due to illness, quarantine restrictions and food/beverage or supply shortages.
